



## **PIOB Certification of The IAASB's International Standard on Auditing 570 (Revised 2024), "Going Concern"**

The Public Interest Oversight Board (PIOB) has overseen the standard-setting process throughout the full development cycle of the International Auditing and Assurance Standards Board's (IAASB) ISA 570 (Revised 2024), *Going Concern* (the 'Standard').

The IAASB has provided a written statement that the Standard has been developed in accordance with agreed due process and is responsive to the public interest, informed by the concepts and principles of the Public Interest Framework (PIF), which is being implemented in the standard-setting process, and which is available in the PIOB website<sup>1</sup>.
